

This partnership will see Interstellar's Blockchain technology stack integrated with Interswitch's industry-leading payments and digital commerce technology. This will enable enterprises using Interswitch to make Bitcoin payments across 5 countries in Africa including Nigeria, Kenya and South Africa.



Ejara Raises \$2million to pioneer usage of Cryptocurrencies in Francophone Africa

Ejara, a Pan African platform that allows access to various investment offers including fractional shares and cryptocurrencies, has raised a \$2million funding round. The platform has more than 8000 users, from Cameroon, Ivory Coast, Mali, Guinea and

Senegal. The company hopes to use the funds for regional expansion and deployment of additional features. Francophone Africa has relatively low adoption of cryptocurrency despite its potential to boost financial inclusion.

Twitch 2021 data breach amplifies concerns about safety, diversity and pay transparency

■Twitch confirmed that a massive cache of internal data, including creator payouts, was published online after a breach. The streaming platform said in a blog post that the leak was caused by an error in a Twitch server configuration change, which was then

accessed by a malicious third party. For many streamers, this leak exacerbates existing tensions over pay transparency in streaming and safety on Twitch. Though Twitch has since added new safety features, tensions remain high in the community.





Multibillion-Dollar Market for Your Phone's Location Data

Currently at an estimated \$12 billion market, the location data industry has many players including collectors, aggregators, marketplaces, and location intelligence firms, all of which boast about the scale and precision of the data that they've amassed. Companies that you likely have never heard of are hawking access to the location history on your mobile phone. Location firm Near describes itself as "The World's Largest Dataset of People's Behavior in the Real-World," with data representing "1.6B people across 44 countries." Mobile-

walla boasts "40+ Countries, 1.9B+ Devices, 50B Mobile Signals Daily, 5+ Years of Data." X-Mode's website claims its data covers "25%+ of the Adult U.S. population monthly." According to Justin Sherman, a cyber policy fellow at the Duke Tech Policy Lab, there isn't a lot of transparency and there is a really, really complex shadowy web of interactions between these companies that's hard to untangle. He further states that these companies operate on the fact that the general public and other regulatory centers aren't paying attention to what they're doing.

Engineering firm director jailed for copyright infringement

An engineering company director has been jailed for a year by a Nairobi court for copyright infringement of a software. Senior Resident Magistrate TN Sinkiyian ordered Kariuki Muchemi, the director of Interconsult Engineers Ltd to pay a fine of Sh120,000 if he is to escape jail. The magistrate further ordered him to pay Ideate technologies, the autho-

rized dealers of the software in Kenya, Sh240,000 as compensation or serve an additional 10 months in prison. Muchemi was convicted of two counts of copyright infringement.

He was found guilty of being in possession of computers containing infringing Auto Card 2009 and 2013 software whose copyright is owned by Autodesk Inc

WHO endorses use of world's first malaria vaccine in Africa

The World Health Organization has recommended the widespread rollout of the first malaria vaccine, in a move experts hope could save tens of thousands of children's lives each year across Africa. After a successful pilot programme in three African countries the RTS,S vaccine should be made available more widely, said the WHO's director general, Dr Tedros Adhanom Ghebreyesus. The RTS,S vaccine, also known as Mosquirix, was developed by the British pharmaceutical



company GlaxoSmithKline (GSK), and has been administered to more than 800,000 children in Ghana, Kenya and Malawi since the pilot programme began in 2019.

Loss of Intellectual Property, Customer **Data Pose Greatest Business Risks**

A recent Dark Reading survey of 215 IT and cybersecurity professionals, identified the types of incidents posing the greatest threat to the organization's sensitive data. Dark Reading's "The State of Incident Response 2021" report shows that security professionals have been most concerned about breaches of intellectual property and business secrets (36%), followed by the unauthorized use of applications by credentialed users (17%). In addition, 16% said outages of internal IT systems, applications, or networks pose big organizational risks.

A group of Democratic lawmakers has demanded that several education technology companies that monitor children online explain their business practices, arguing that around-the-clock digital surveillance demonstrates "a clear invasion of student privacy, particularly when students and families are unable to opt out."

Digital identity trust scheme pilot for home buying and selling

Propertymark is working with Etive and other industry stakeholders on a project to develop a digital identity trust scheme for the home buying and selling sector. Aligned to the eventual UK Digital Identity and Attributes Trust Framework that is being developed by the Department for Digital, Culture, Media and Sport (DCMS), the development of the Scheme, known as MyIdentity, will allow the digital identity of a home buyer/seller to be verified once and then be shared by the consumer used

throughout the rest of the sales transaction, based on consent. The Scheme is for the complete home buying and selling process/transaction and is expected to have active involvement from all key stakeholder groups including estate agents, conveyancers/lawyers, mortgage intermediaries, mortgage lenders, new home developers and identity providers serving the market. The Scheme will <u>initially run d</u>uring a Pilot Phase from the end of October for six months in specific areas.

Tamil Nadu police's 'Face Recognition Software' has privacy experts worried

Tamil Nadu Chief Minister MK Stalin on October 4 announced a Face Recognition Software (FRS) to aid the state police in its investigations. The software, according to the government, will help compare the photos of suspects with a data resource of over 5.30 lakh photos updated in the Crime and Criminal Tracking Network Systems (CCTNS). An official statement from the state police said that the software will help track down accused persons, suspected persons, and missing persons. It will

also help in identifying corpses by comparing with the data available with the CCTNS. The software will also share the information about a person to all other police stations and help nab the accused if they happen to commit an offence in another police station limit. However, privacy experts have raised several concerns, including that of mass surveillance and violation of the right to privacy. Some have pointed out that such a technology should be introduced along with a law to regulate usage.




