Rwanda passes new law protecting personal data

■ Rwanda's law on the protection of personal data and privacy was officially gazetted on 15th october 2021. The law now brings Rwanda in line with international data protection standards, which is vital for the digital economy facilitating services such as e-commerce, international financial transactions and various online services. With the transmission period ending on 15th october 2023, the passing of this law begins a two-year journey to compliance, allowing individuals and institutions to put in place the necessary processes to ensure personal data is handled in a trusted and secure manner.

Dublin Circuit Court confirms €450,000 fine for Twitter delay in reporting data breach

The Dublin Circuit Court (DCC) on Monday confirmed the Irish Data Protection Commission (DPC) decision to fine Twitter €450,000 for its delay in reporting a data breach. The fine, imposed in 2020, was implemented when Twitter failed to report a General Data Protection Regulation (GDPR) data breach in enough time. The breach related to Android users who had changed their settings to make tweets private and could have had their data exposed due to a bug. It was found that the delay in reporting this breach infringed Article 33 (1)(5) of the GDPR. The DCC confirmed the legitimacy of the fine, in line with section 143 of the Data Protection Act 2018.

Dell Technologies 2021 Global Data Protection Index findings on data protection measures for businesses

Sixty-six per cent of businesses in India fear that their existing data protection measures may not be adequate to cope with cyber threats, while 74% agree they have increased exposure to data loss with the growth of employees working from home, according to the findings of the Dell Technologies 2021 Global Data Protection Index (GDPI). The findings re-

vealed that 70% of respondents in India believe emerging technologies such as cloud-native applications, Kubernetes containers, artificial intelligence, and machine learning pose a risk to data protection, and the lack of data protection solutions for newer technologies was one of the top three data protection challenges for organizations.

Consumer protection agency probes how apple, Facebook, amazon use financial data


Big tech companies are facing questions from the government on how they use consumers' financial and other information. The Consumer Financial Protection Bureau said it had launched an inquiry on consumer data practices at Amazon.com Inc., Apple Inc., Alphabet Inc.'s Google and Facebook Inc. amongst other firms. The bureau issued orders seeking information from the companies that would

help it better understand how these firms use personal payments data and manage data access to users. CFPB Director Rohit Chopra said he would make it a priority to look into issues such as data privacy and further that it would be critical for the CFPB to take a hard look at how big tech companies and others are entering financial services, the impact on our privacy and our personal data.





DIGITAL ID



Hacker steals government ID database for Argentina's entire population

A hacker has breached the Argentinian government's IT network and stolen ID card details for the country's entire population, data that is now being sold in private circles. The date includes full names, home addresses, birth dates, gender info, ID card issuance and expiration dates, labor identification codes, Trámite numbers, citizen numbers, and government photo IDsThe hack targeted RENAPER,

translated as National Registry of Persons, and tasked with issuing national ID cards to all citizens, data that it also stores in digital format as a database accessible to other government agencies, acting as a backbone for most government queries for citizen's personal information. The hacker has threatened to release the data to the public and to continue selling access to this data to all interested buyers.

Malaysia Govt to introduce Digital ID system

■ In line with the current need for digital and online services and transactions, the government is set to introduce the Digital Identity (Digital ID) initiative, said Datuk Seri Hamzah Zainudin, incharge for Home Ministry and National Registration Department (NRD). The initiative is in line with the government's aspiration to empower the digitisation of technological and government services at high

capacity through an endto-end approach that can be utilised by the people and at the same time drive the development of the country's digital economy. The Digital ID will be a form of digital identification and authentication for individuals by using the latest biometric technology such as fingerprints, facial and iris recognition while conducting matters online.

Scotland Schools let students make contactless meal payments with their face



Students at secondary schools in North Ayrshire in Scotland can now opt to make contactless payments for their school meals and snacks by authenticating their identity using biometric face recognition technology. Nine schools have implemented the system, enabling students to select their meal and authenticate payment from a prepaid online account by looking into a camera at the point of sale. This truly contactless identification method means catering teams can safely increase their speed of service by simplifying the payment process for students, who no longer need to carry any form of identification such as a card or even enter a PIN.

UK Health Secretary Hopes AI can Tackle Racial Inequality



■ UK Health Secretary Sajid Javid this week approved a series of AI-based projects that aim to tackle racial inequalities in the NHS. The projects

include, the creation of new standards for health inclusivity to improve the representation of ethnic minorities in datasets used by the NHS and the development of an AI-powered chatbot to raise the uptake of screening for STIs/HIV among minority ethnic communities

Russian court bars sale of Samsung phones over patent lawsuit

■ A Russian court has barred Samsung Electronics from importing and selling 61 models of smartphones in Russia over an intellectual property lawsuit pertaining to its Samsung Pay system. The lawsuit filed by Switzerland-based company SQWIN SA claims that Samsung Pay infringes on its electronic payment system patent registered in Russia.

U.S. Urges All WTO Members to Support Intellectual Property Waiver for COVID-19 Vaccines

■ The White House has called on all World Trade Organization members to support an intellectual property waiver for COVID-19 vaccines, citing the need for every WTO member to step up as well and support an intellectual property waiver, and every company must act ambitiously and urgently to expand manufacturing. This comes a year after South Africa and India introduced a proposal to temporarily waive intellectual property rights on COVID-19 vaccines and therapies at the WTO, and negotiations failed to make any progress. While more than 100 countries backing the waiver say it will help save lives by allowing developing countries to produce COVID-19 vaccines, the European Union and several countries, including Switzerland, remain opposed.

Facebook signs copyright agreement with French publishers

■ Facebook has signed a preliminary copyright agreement with a French news publishers' lobby group, paving the way for it to pay for news content on its platforms in France. The accord takes the form of a "term sheet" of a few pages, with the preliminary deal listing the main principles of the accord and the copyright fees due to each of its members. The "term sheet" is expected to soon be followed by a framework agreement that will allow APIG's members to sign individual licences with Facebook. Further, there will be two types of licences, the source said: one for the use of news content on Facebook's main platform and one for its upcoming Facebook News service, which will curate stories from a select set of publications.

Apple Launches New MacBook design, AirPods and Voice Plan at Apple Unleashed Event

Apple's prerecorded Unleashed event revealed updates to Apple Music and the Mac, including new processors and a redesign for the MacBook Pros. In this year's MacBook, the company chose to get rid of the touch pad introduced in 2016, bringing back the popular magic keyboard design. Other changes include the return of the HDMI port and SD card slot along with MagSafe charging.

Apple also announced the Airpods 3 with spatial audio capabilities. Spatial audio initially debuted on the Air-Pods Pro and AirPods Max. With AirPods 3, users will get an all-new design with Force Sensors for control. There are also new drivers for powerful bass and crisp high frequencies.


