Afreximbank partners with AfCFTA and The African Union for the launch of The Pan-African Payment and Settlement System

■ The Pan-African Payment and Settlement System - PAPSS - enables the efficient flow of money securely across African borders, minimizing risk and contributing to financial integration across the regions.

PAPSS collaborates with Africa's central banks to provide a payment and settlement service to which commercial banks, payment service providers, and fintechs across the region can connect as 'Participants'.

The system will help facilitate increased cross-border payments in the region.



This Week in Fintech Newsletter Launches Fintech Fund focused on early-stage startups

■ Nik Milanovic of This Week in Fintech Newsletter is now looking into investing in early-stage fintech ventures through the Fintech Fund.

Speaking to TechCrunch, Nik stated, 'The goal is to make this a community fund, rather than an undifferentiated out-of-the-box fund. Our focus is to give the people & institutions working deeply in fintech a way to reinvest in the fintech

The Fintech Fund is investing at the preseed and seed stages and has backed ten companies so far, including Goldfinch, 3Box, Ponto and Paysail.



Electric Mobility Startup Opibus debuts first-ever electric bus designed and developed in Africa


Opibus this week introduced the first all-electric bus in Kenya and the first African-designed electric bus ever. The bus will be significantly lower cost than importing fully built electric buses with superior performance than its diesel counterpart. Considering the electricity charges, which are also substantially lower than the ever-increasing diesel price, the total operating expenses are lowered by 50%. The innovation is set to revolutionize the public transport sector in Africa.



LEGALTECH NEWS

Report by Law360 Reveals insights into the LegalTech Market in 2021

According to Law360, Legal technology had a record year of investments in 2021, with at least \$9.1 billion through funding or mergers and acquisitions involving companies in the industry. Contracts and e-discovery were the most funded innovations, with minimum investment in alternative dispute resolution and courts.

Celo Launches the cREAL Stablecoin

Celo has launched Celo Real (cREAL), its third stablecoin for mobile payments, in Brazil. This makes Brazil the first — and only — country with a Celo stablecoint, accepted as payment and used to access DeFi apps and services without regional friction.

Facebook and Instagram explore plans to let users trade NFTs

■ Meta is exploring plans to allow users to create and sell non-fungible tokens (NFTs) on Facebook and Instagram. This would be the biggest show of mainstream support for NFTs to date if launched.



Twitter Launches feature allowing users to display NFTs on their profiles

■ Twitter is working on a tab that allows users to show off their NFT collection. Users will be able to connect their wallets to their profile and select preferred NFTs that they would like to use as their profile pictures. Users will also be able to tap through to a page that shows detailed information about the NFT, including a description, its creator, and properties.

Entebbe Municipal Council, Sunbird Al Sign MoU to Curb Noise Pollution in Entebbe

The Entebbe Municipal Council and Sunbird AI have signed a Memorandum of Understanding to use Ugandan-built noise monitoring sensors to measure, monitor, and record levels of noise and noise pollution in Entebbe. This is part of a larger initiative by Sunbird AI to do environmental sensing. Sunbird AI is a not-for-profit organization focusing on Artificial Intelligence (AI) for social good. Sunbird AI executes its mandate through the development of practical AI solutions for societal challenges which contribute to the generation of evidence for policy



DATA PROTECTION

Kenya's Office of the Data Commissioner Launches Strategic Plan and Curriculum

The government of Kenya has assured its citizens of the safety of their data saying that it has made tremendous steps towards safeguarding personal information with the recent gazettement of the Data Protection Regulations 2021. ICT, Innovation and Youth Affairs CS Joe Mucheru said that other measures that the government has taken to ensure safety of data is the establishment of the office of the Data Commissioner and the launch of the first Data Protection Curriculum for the country at Kenya School of Government (KSG). These remarks were made during the International Data Privacy day and the launch of the strategic plan for the office of the Data Commissioner and data protection curriculum held at the Kenya School of Government, Nairobi. The CS said that the strategic plan was an embodiment of the commitment of the government in ensuring that the reg ulatory environment for personal data in Kenya is conducive and enabling in the digital era as envisioned in the Kenya Vision 2030 and Third Medium Term Plan 2018-2022.

Other measures that the government has taken to ensure safety of data is the establishment of the office of the Data Commissioner and the launch of the first Data Protection Curriculum for the country at Kenya School of Government (KSG).



Armenia ratified the Convention 108+ on data protection



On 25 January 2022, Ambassador Arman KHACHATRYAN, Permanent Representative of Armenia to the Council of Europe, deposited the instrument of ratification of the Protocol amending the Convention for the Protection of Individuals with regard to Automatic Processing of Personal Data (CETS No. 223), known as Convention 108+, bringing the number of ratifications to 16.

The Protocol aims to modernize and improve the Convention 108, the only binding international instrument with global relevance in this field. It addresses the new challenges to the protection of privacy resulting from the use of new information and communication technologies having emerged since the adoption of the Convention in 1980. The Protocol strengthens the Convention's mechanism to

ensure its effective implementation by introducing innovations and constitutes a bridge between different regions of the world and different normative frameworks, including the new European Union's legislation in the context of transborder data flows.



INTELLECTUAL **PROPERTY**

Saudi Ministry of Commerce, SAIP tighten grip on counterfeiters

■ The Ministry of Commerce and Saudi Authority for Intellectual Property are winning the battle against counterfeiting and fraud in the Kingdom, the authority's spokesman told Arb News.

A recent high-profile case involving a social media influencer, who was caught red-handed by authorities after selling counterfeit goods, demonstrated the need to fight fraud in the Kingdom. Yaseer Hakami, spokesman for the Saudi Authority for Intellectual Property, said that the authority made 1,912 online inspection visits during 2021. It further conducted 282 visits to promote awareness of intellectual property rights and obligations.

The Authority also recommended 2,079 websites to be blocked for violating the Kingdom's intellectual property laws, made more than 6,400 field inspection tours in 10 cities that resulted in the confiscation of more than 95,000 items.

Meta goes Brazil to trademark


Meta, the world's biggest social media platform, has filed a trademark registration with the Brazilian authorities to design, develop and provision hardware and software for various Bitcoin (BTC) and crypto-related services. Meta recently rebranded from Facebook as a move to better align with the Metaverse developments despite regulatory attempts to enter the crypto space

Accelerating this effort, Meta filed a tradetional Institute of Industrial Property (INPI) for crypto products and services related to trading, wallets and exchanges platforms. It published the application for registration on Jan. 25 and is currently awaiting opposition prior INPI approval.

DIGITAL IDENTITY

Indian Govt Working on 'One Digital ID' That Links PAN, Aadhaar, Passport

■ The Central government is seemingly working on the successor of the Aadhaar Card. According to the Ministry of Electronics and Information Technology's (MeitY) proposed plan the government is working on a new model of "Federated Digital Identities" to link multiple digital IDs such as driving licence, passport numbers, PAN, and so on- all into one. This new digital ID will seemingly be present in the form of a unique ID, similar to the Aadhaar card number. The proposed plan suggests the umbrella digital identity will "empower" a citizen by "putting her in control of these identities and providing her with the option of choosing which one to use for what purpose." The Federal Digital Identity will also seemingly serve as a one-stop destination to store Central and State-related ID data. As expected, this digital ID could be used for KYC or eKYC (know your customer) processes.



Pakistan's Nadra converting ID cards into digital wallets

■ The National Database and Registration Authority (Nadra) is working to make the computerised national identity cards digital wallets under the government's Digital Pakistan vision and an update to an already existing app will likely be made available later this year. "Translating this vision into reality, we have launched the 'Pak Identity' mobile app as a key building block of digital ID to facilitate applicants of national identity cards through an online portal. The app helps capture biometric fingerprints, facial recognition and scan documents needed for processing a person's ID card using smartphones, without visiting a Nadra office or embassy," Nadra chief Tariq Malik said. He further explained that in a short span, 75,000 overseas Pakistanis have processed their national identity cards [called Nicop] from the comfort of their homes by using the app, which is supported by two-factor authentication. The app is available on both Android and iOS platforms.

U.S. Treasury Weighs Alternatives to ID.me After Privacy Concerns Raised

■ The U.S. Treasury said it is considering alternatives to facial-recognition technology by commercial provider ID.me to verify identities for online taxpayer accounts after some lawmakers raised privacy concerns. The Internal Revenue Service announced in November that it will transition this year to identity verification using ID.me technology for accessing online services including tax records and Child Tax Credit information. The process involves uploading a "selfie" photograph to create an ID.me account and gained more attention this week as the IRS kicked off its annual tax return filing

Senate Finance Committee Chairman Ron Wyden said on Twitter that he was "very disturbed" by the prospect of taxpayers submitting to facial recognition while Representative Ted Lieu, a California Democrat, called the move a "very, very bad idea," adding that facial recognition is less accurate with dark skin tones. The American Civil Liberties Union called the ID.me facial recognition technology "biased" and "glitchy."

"The IRS is consistently looking for ways to make the filing process more secure but to be clear, no American is required to take a selfie in order to file their tax return," the department said in a statement.
